Governing Rules: The latest International 29er Rules as posted by the ISAF on www.sailing.org, and the Racing Rules as prescribed by US SAILING.

Eligibility: Any two person crews in a 29er.

Entries: Checks should be made out to **Conanicut Yacht Club**. Mail entries to 29er East Coasts, Conanicut Yacht Club, PO Box 257, Jamestown, RI 02835 USA. Entry fee for team is US\$100 if entry is postmarked by July 20, 2007. US\$130 for entries made on site.

Launching and 29er Storage: Launching via ramp at CYC. 29ers to be kept on lawn at CYC.

Trailers: Shall be stored at Conanicut Marine's storage lot under the bridge. Absolutely no trailers to be left at CYC.

Coach & Support Boats: Moorings or dockage is available from Conanicut Marine (may@conanicutmarina.com or tel 401-423-7157), a short walk South of CYC. Powerboats may be launched from the town ramp along the town beach just South of CYC. No powerboat launching from CYC.

Sailing Instructions: Will be available at Check In on Thursday, August 7.

Courses: Detailed in the Sailing Instructions.

Scoring: Low point

Awards: Trophies will be presented for the top five finishers.

Accommodations: Housing not provided. The Bay Voyage Inn (<http://www.bayvoyageinn.com>) is located in Jamestown, next to CYC. Plenty of other hotels and motels available just over the bridge in lively Middletown and Newport.

ASSUMPTION OF RISK, WAIVER OF LIABILITY, SWIMMING CERTIFICATION AND PHOTOGRAPHIC RELEASE

I, the undersigned, parent/guardian of _____, a minor, recognize and understand that participation at the 29er East Coast Championship at Conanicut Yacht Club in Jamestown, RI (the "Regatta"), is voluntary, that the decision whether to participate rests exclusively with my child and me, and that my child incurs risks by participating, including the possibility of bodily injury or even death, and I confirm that I hereby assume on behalf of my child such risks. In consideration for allowing my child to participate in the Regatta, use of the facilities of Conanicut Yacht Club, and other facilities and locations, I hereby waive and release any claims that I or my child may have against Conanicut Yacht Club, providers of other facilities, and any of their respective officers, directors, agents, servants, employees, volunteers, parents, sponsors, coaches, participants and contributors for any and all injuries suffered by my child at the Regatta, or while practicing for or participating in the Regatta, or while traveling to or returning from the Regatta (excluding claims against owners, lessees and/or drivers of motor vehicles). I also agree that my child will abide by and be bound by the Racing Rules of Sailing, and that I am responsible for the actions and conduct of my child while he or she participates in any such event or activity including while on land at the host facility. I understand and agree that my child may be removed from the Regatta for bad behavior including bad sportsmanship, failure to obey coach or Organizer instructions or disruptive behavior.

SWIMMING CERTIFICATION
