The Organizing Authority (OA) for this regatta is Cabrillo Beach Yacht Club (CBYC).

### 1. RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2 A US Coast Guard approved personal floatation device shall be worn, properly fastened, by all competitors at all times while launching and sailing.

### 2. ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to all boats of the 29er class.
- 2.2 All competitors (skipper and crew) shall be current members of the USA 29er Class Association. USA 29er Class Association membership applications and dues will be accepted during Registration.
- 2.3 Entries may be made at [www.CBYC.org](http://www.CBYC.org), by mail sent to CBYC at 211 W. 22<sup>nd</sup> St, San Pedro, CA 90731, or in person during the registration periods listed in the schedule.
- 2.4 An entry will considered complete only when the Entry Form (or online equivalent), Parental Consent Form (for competitors not yet 18 during the regatta) and Liability Release forms are submitted, competitor membership in the USA 29er Class Association is verified, regatta entry fees paid, and competitor's equipment has been given an "OK to complete" by the Equipment Inspection Committee.
- 2.5 Entries will close at 1000 hours PDT on Friday July 23, 2010.

### 3. FEES

- 3.1 The entry fee is \$200.00 for entries received before July 16, 2010 and \$225.00 thereafter.
- 3.2 The entry fee provides complimentary continental breakfasts on Friday thru Sunday, two (2) dinner tickets to the 29er Annual General Meeting and Dinner, two (2) shirts and complimentary hors d'oeuvres at the prize giving.
- 3.3 Additional dinner tickets for the 29er Annual General Meeting and Dinner may be purchased for \$15.00. Additional shirts maybe purchased for \$30.00.
- 3.4 Competitors may dine at the CBYC dinning room with charges to be paid separately.

### 4. SCHEDULE

- 4.1 A maximum of eleven (11) races shall be sailed with four (4) races scheduled for Friday and Saturday and three (3) races on Sunday.
- 4.2 The schedule of events is as follows:

## 5. EQUIPMENT INSPECTION

- 5.1 Competitors shall present their 29er boat and sails for inspection during the times listed in the schedule.  
 5.2 Boats shall be presented in reasonably dry condition. Additional requirements on where the boats shall be presented and what configuration they shall be presented will be provided at registration.

## 6. SAILING INSTRUCTIONS

- 6.1 Sailing instructions will be available at the CBYC Race Office during the registration periods listed in the schedule.  
 6.2 The CBYC Race Office is situated at Cabrillo Beach Yacht Club and will be open from 0900 PDT daily.

## 7. VENUE

The races will be conducted in the Pacific Ocean adjacent to San Pedro, California; either inside or outside the breakwater.

## 8. SCORING

- 8.1 The Low Point Scoring system will apply except that a boat's score shall be the sum of her races if fewer than six (6) races are completed. This changes RRS A2.  
 8.2 Three (3) races shall be completed to constitute a series.

## 9. PRIZES

Prizes will be awarded for the top three (3) teams, the first junior team (both skipper and crew not yet 19 years old by December 31, 2010) and the first all-women team.

## 10. PHOTOGRAPHY CONSENT

Competitors entering the regatta accept that they may be photographed and/or video taped participating in the race and/or using Cabrillo Beach Yacht Club's facilities and they consent to the taking of such images and to the use, reuse, publication and republication of such images in any media, in conjunction with the competitors name or not without compensation and without the competitors approval of such images or any use thereof.

## 11. COACHES AND NON RACE COMMITTEE BOATS

- 11.1 All boats and coaches intending to be near the racecourse must register with the OA at Registration.  
 11.2 All boats and coaches must be capable of communicating with the Race Committee on VHF channels 16, 68, 69, 71 and 73.
